Mayor Cooner and Council had much discussion of bids that were received for work to be completed at the old Lockett School Mayor Cooner stated that in November 2010 there was a mandatory pre-bid conference for that work and that only one contractor was present and that was Ronnie Maxwell with Maxwell Construction, Contractor Jeremy Williams from Ridgeway had mailed his bid in to the Town office a week or so later Mayor Cooner then said that Jeremy Williams had bid between 10 to 12000.00 and that Ronnie Maxwell had bid 8,775.00

Councilman Chris Ott said to throw out the bid from Mr. Williams because he did not come to the pre-bid conference

Councilman Chris Ott made the Motion to hire Ronnie Maxwell to do the work for securing the old School Councilwoman Benita Gibbs seconded the Motion Motion Carried
